NFCA Membership Classes

The National Fireproofing Contractors Association is focused on the needs of the fireproofing industry. The following membership classes are offered to ensure all qualified companies can participate in shaping the fireproofing industry.

Regular Contractor Member – A proprietorship, partnership or corporation engaged in the business of furnishing and installing passive fireproofing shall be eligible for membership as a Regular Contractor Member. A Regular Contractor Member must have completed 2 years and 20 jobs in the passive fireproofing business. Contractors must provide a list of project names and locations to be considered for membership.

Interim Contractor Member – A proprietorship, partnership or corporation engaged in the business of furnishing and installing passive fireproofing shall be eligible for membership as an Interim Member and must have completed 5 jobs in the passive fireproofing business before becoming an Interim member.

Supplier Member – A proprietorship, partnership or corporation in the business of supplying products used by contractors in the installation of passive fireproofing shall be eligible for membership as a Supplier Member.

Associate Member - A proprietorship, partnership, corporation or unincorporated association engaged in the business as a non-product supplier, consultant, testing company, or independent representative providing services to the contractor installing passive fireproofing shall be eligible for membership as an Associate Member.

Honorary Member – Any person who, in the opinion of the Board of Directors, has demonstrated sufficient interest in the passive fireproofing industry shall be eligible for consideration as an Honorary Member of the Association.
