NFCA SUPPLIER MEMBERSHIP APPLICATION

Manufacturer suppliers of fireproofing applying for NFCA Membership must have completed product fire-resistance testing to test standards required by codes in the region of the world they do business in. For example, in the United States, testing shall comply with standards required by the International Building Code, NFPA 5000, NFPA 101, including ASTM E119/UL263 and/or UL1709, large scale, with load applied. Load applies to horizontal assemblies, beams, and joists. For columns, loading is optional. In Canada, testing shall meet requirements of the National Building Code of Canada, including CAN/ULC-S101, with load applied for horizontal assemblies and beams. Loading is optional for columns. Test Standards must not be "Modified." Testing must be full-scale fire-resistance testing at a "Nationally Recognized Testing Laboratory" or "Approved Agency" as defined by the International Building Code. Applicants must provide test results either individually or via reference to listings on a fire test laboratory website and product technical literature showing product usage, proving suitability of use of the products in specific applications for horizontal assemblies, joists, beam, and columns.
